Iron Gate requires a deposit of \$\_\_\_\_\_ to hold a position on our waiting list for a current or upcoming unborn litter. Deposit can be made with cash, \*check, or money order. By the form of a signature, the client listed above indicates his/her agreement in the policies and procedures listed as follows:

1. All waiting list positions must be secured by a \$\_\_\_\_\_ deposit delivered to Iron Gate by mail or in person. This deposit will be applied to the total purchase price of your \_\_\_\_\_. Please make all checks payable to Monique Diamond-Kilmer, and mail to P.O. Box 64, Alanson, MI 49706
2. All waiting list positions are listed in order of receipt of deposit and/or initial contact.
3. All waiting list deposits are non refundable with no exceptions unless:
  - a. Your preference of sex of dog is not provided or whelped and you do not wish to have the opposite sex or wait for the next litter.
  - b. Your preference of color of dog is not provided or whelped and you do not wish to have an alternate color or wait for the next litter.
4. Refundable deposits will be returned through the mail or in person following whelping and within the first two weeks of the whelp of the litter.

5. Clients can change their mind on preference of color or sex of dog prior to whelp or after, providing that color or sex is available. We will not bump others clients on the list if you change your mind. You must wait until the litter is whelped to see if your change is available.
6. Iron Gate will notify clients within 1 week of the litter being whelped and of availability.
7. Balance of purchase price is to be paid by the time the pups are 7- 8 weeks of age or when you pick up your pup, which ever comes first. Balance of purchase price is to be made by cash only.
8. No dog or pup will leave Iron Gate without being paid in full.
9. The seller has a right to cancel this contract at any time before puppy pick up (with return of deposit), if seller deems circumstances are warranted. (If puppy is paid in full, seller will return purchase price, plus deposit, minus expenses) **This refund is only applicable if seller cancels this contract!**
10. Puppies will only be held past the date of \_\_\_\_\_ by prior arrangement with the seller. Purchaser shall be responsible for subsequent board (\$25 per day), food and veterinary fees.
11. Seller may sell any puppy held past the date of \_\_\_\_\_ (unless prior arrangement has been made) with buyer forfeiting deposit and all claim to puppy. If puppy has been paid in full, seller will return purchase price, minus deposit. Any expenses incurred by seller shall be deducted from any returned monies owed to buyer.
